The objection shall specify the portions of the proposed rule to which the person objects and the specific reasons for the objections.

**POLICY IHAM Local School Wellness**

**Purpose and Effect:** This policy is required to be reviewed annually.

**Summary:** No substantive changes are recommended during this year's annual review.

**Summary:** Revisions to existing language includes content, formatting, and terminology edits.

#### **POLICY JJC Student Performances**

**Purpose and Effect:** This policy is being revised to add “or designee” to the principal’s approval when it comes to public appearances of school groups.

**Summary:** Revisions to existing language includes content, formatting, and terminology edits.

**Specific Authority:** §§1001.54; 1006.08; 1012.28, FS

#### **POLICY KB Parental Involvement in Education**

**Purpose and Effect:** This policy is being revised to include the requirements of the Parents’ Bill of Rights (HB 241) (2021) and Parental Rights in Education (HB 1557) (2022). The proposed revisions track the requirements of §§ 1014.05(1) and 1001.42(8), FS.

**Summary:** Revisions to existing language includes content, formatting, and terminology edits consistent with statutory changes.

**Specific Authority:** Chapter 1014 and §§1000.21; 1001.32; 1001.41; 1001.42; 1001.43; 1001.51; 1001.54; 1002.20;1002.23; 1008.25; and 1012.98, FS; 20 USC Section 6318; 34 CFR Section 76.700
